Beside that you declare your "members" "prancinghorse" and "franzdebyl" as "contributors" to these data - what is ridiculous and untrue. Beside that you maintain several so called forum sites what are to be seen for everybody - and found by search engines all over the world. You calculatedly made it like that to use your "forums" for your promotion, like you can see here in 2 examples

You know well that I am willing you to remove all this content since more than four years now and that I already wrote a DMCA complaint to Google about that. Google removed the main discogs page from the search results but that didn't matter to you because you still use the other possibilities of leading and linking all the people to the above named site. Worldwide.

I have to tell you that I now can fully substantiate that this LP was and is prohibited since 1971. And ALL copyrights are in MY hands - ALL!

Every further or new publication of this LP and every dealing of original LPs from the first and only circulation on - so all what you are doing - is forbidden and prohibited since 40 years now.

I told you about this more than only one time. Your forums are full of my interventions against discogs concerning this case. But you only spitted out that this record is in the market place and your members want to sell and buy it...

I still have all those "discogs" emails - mostly from Mr. "Nik" - and can easily aver that everybody at discogs knows about the case. Btw: Since 2 years this LP is on the index of "Verisign" - you cannot buy or sell it at Ebay's and other seller's market place. You know that too as one can read in your forums.

So please take this my letter to you as your last chance to remove the above specified content and ALL linking sites from your servers. I give you at least 5 more days to do so. Especially I want you to remove and erase all letter spelling "Heiner Hohnhaus" from all your HTML content - no matter if you mentioned this name on your seller sites or your forums.

This letter will be sent to you by email to the only two addresses what can be found on "nic.com" and "who.is" and others IP numbers search engines and I am asking you to reply on it within the next 5 days. If you don't answer this mail, this letter will also be published in the WWW and sent to all my friends in Europe and the US, Japan and Russia.

Last but not least I will send this letter to the german embassy in Portland and ask The Consul attended by the local police to give it to you personally with your confirmation of receipt that I can file a charge against you and your company.
