Dear Ladies & Sirs,

I received your above mentioned letter and took note of your explanations.

Before I respond I would like to let you know that I just erased my profile on Last.fm and all tags and everything I could erase at Last.fm as a member. All music I once uploaded was erased from me for a long long time already - but it is still on your server like you confess it yourself. "My" Last.fm artist site was on your server too, long before I tried to create my own profile, so your copyright abuses last very much longer than only from the day I became a member of your - excuse me - naughty club.

I made me to become a member because I was hoping that I could create my very own profile including music, pics, life story and all the tags and stories and... like one can do it in facebook, my space, youtube a.s.o.

When I realized that Last.fm is only interested in expropriating musicians and their names and that one cannot change personal history facts or tags and others I tried to erase all content what I uploaded before instantly. After that I only still stayed a member just for reasons of controlling your users, what they gonna do with my "artist site".

Those are the concerns about my membership with Last.fm what was determined 1 hour ago.

Now let's come to your assertions about Google. Please don't try to fool me therewith, when Google finds a search result like this

...then Google finds it in the Last.fm server domain's HTML source and this fact is only due to yours and your webmaster's work (MetaTags, MetaNames etc. you filled in, NOT Google). Google and others ARE NOT TO BLAME! It's ONLY YOUR RESPONSIBILITY!

And you did a very good job: This Last.fm search result can be found world wide and in all current languages including russian, chinese a.s.o. - here an example in french:

You never have been allowed to write HTML programs and web sources by using my name and trade mark in this way!

So I will send a copy of your letter to Google and ask them to please explain the function of google search for simple people like judges and lawyers in case I will need it for an impeachment against you. Guess you know like I know what they will answer?

Yes Sirs, Google can only find what is written in the source of YOUR website's HTML text.

Only you did it. And the only one to change or to remove it is again you! Nobody else can!

What you're trying to lay on your member's doors is nothing but your own fear, you cowards. You are only trying to hide behind your "bad & criminal" members. But your members can only do what you allow them to. You are the dealer in stolen goods.

Therefore I want you to remove and erase ALL "FRANZ DE BYL" CONTENT FROM ALL YOUR SERVERS AND WEBSITES AND HTML TEXT AND ALL LAST.FM WHATEVER! WORLDWIDE!!!!

What you did in Germany is not good enough for me! You blocked "my" artist site in telling the people that there is, or might be inappropriate content! What's that? Using my name to tell the people that there is inappropriate content? You're joking, don't you?

I give you at least another 7 days to totally erase the quoted content and send me a note that you did by email.

Otherwise I will sue you and your whole company in London.
